# **Traveling Tips for K-State International Students**

# When traveling outside the U.S., what do I need to reenter the U.S.?

- 1) Valid passport (valid at least 6 months into the future)
- 2) Valid visa (exceptions: see automatic visa revalidation below)
- 3) Valid I-20 or DS-2019 with a recent travel signature (complete the request form on the ISSS website)

# You should also carry the following and have them readily available if asked by U.S. Customs and Border Protection (CBP)

- 4) I-94 card/printout (available to download/print for free on the CBP website)
- 5) I-901 'SEVIS Fee' Receipt Notice (available to download/print for free on the U.S. Immigration and Customs Enforcement [ICE] website)
- 6) Official transcript and/or certificate of enrollment from Registrar's Office (118 Anderson Hall)
- 7) Proof of finances to support your stay (your financials are listed on your I-20 or DS-2019, but you could also carry other documentation which verifies that information such as a bank statement or assistantship letter).

# Do I need anything else if I am on Optical Practical Training (OPT) or the STEM OPT Extension?

### When traveling inside the U.S., what should I carry?

It is recommended that you carry all your immigration documents with you.

#### Do I need to renew my visa if I travel abroad?

If your non-immigrant visa stamp has expired, you will have to apply for a new visa to re-enter the U.S., unless you will be using Automatic Visa Revalidation (see below). Speak with an international student advisor at ISSS before you leave the U.S. to apply for a visa renewal.

#### What is Automatic Visa Revalidation?

{Found at 22CFR Section 42.112(d) and on the U.S. Department of State's website.}

Students & their dependents in F or J status may re-enter the United States with an expired visa after traveling solely to Mexico, Canada, or an adjacent island in the Caribbean (except Cuba) if the travel is for 30 days or less. Adjacent islands include Saint Pierre, Miquelon, the Dominican Republic, Haiti, Bermuda, the Bahamas, Barbados, Jamaica, the Windward and Leeward Islands, Trinidad, Martinique, and other British, French, and Netherlands territories or possessions in or bordering on the Caribbean Sea.

#### Am I eligible for Automatic Visa Revalidation?

# • Eligible individuals must:

- o have not been absent from the U.S. for more than 30 days and was solely in a contiguous territory or adjacent island;
- o have maintained and intends to resume their current status;
- o be in possession of a valid passport, unless exempt from passport requirements. (Individuals carrying new passports issued from within the U.S. to replace an old passport that contains the original nonimmigrant visa may qualify for automatic visa extension **only if** they have the old passport in their possession.);
- o present a current, valid I-94, (do not surrender the I-94 upon your departure);
- o present a valid I-20 (if in F status) or valid DS-2019 (if in J status) which shows an unexpired period of authorized stay and has been endorsed by an international student advisor for travel.

# • Individuals NOT eligible:

- o The automatic extension rule does NOT apply to nationals of countries the U.S. has identified as sponsors of terrorism which include: Cuba, Iran, Sudan and Syria.
- o Those who apply for a new visa while abroad in Mexico, Canada or an adjacent island are not eligible to re-enter the U.S. under Automatic Extension of Visa.
- o Individuals who are out of status in the U.S. or whose visa has been canceled are not eligible for this benefit.
- Automatic revalidation does not apply to the Visa Waiver Program. Readmission to the U.S. after departure to contiguous territory or adjacent islands for Visa Waiver Program applicants is covered under 8 CFR 217. 3(b).

\*Even if you are eligible for Automatic Visa Revalidation, it would be advisable to talk with your international student advisor/ISSS before departing the U.S. if you plan to use it to re-enter.

# Can I renew my U.S. visa in Mexico or Canada?

If you are planning to apply for a U.S. visa in Mexico or Canada, please talk to an advisor at ISSS first. In general, *ISSS does not recommend that third-country nationals apply for a U.S. visa in Mexico or Canada* because of lengthy delays due to background/security checks and complications in case of visa denial. If your visa application is denied, you would need to depart directly to your home country to apply for a new visa to reenter the U.S. Moreover, recent <u>notices</u> from the U.S. Department of State have stated that "Applicants for U.S. nonimmigrant visas should schedule their visa interview appointments at the U.S. Embassy or Consulate in their country of nationality or residence."

#### Do I need a visa to enter another country?

If you are traveling to or through any country that is not your country of citizenship, you may need a visa to enter that country. The following contacts may be helpful to determine if you need a visa to enter another country:

# Is there anything else regarding traveling that I should know?

### • Travel Signatures:

- o Please submit the request form to ISSS.
- o Processing time for travel signatures is 2-3 business days, so be sure to plan ahead.
- o ISSS will issue you a new I-20 or DS-2019.
- o If you are a J-1 student and K-State is not your program sponsor (listed in #2 of DS-2019), you will need to mail your DS-2019 to your sponsor (e.g. IIE, Fulbright, LASPAU) to get a travel signature.

# • <u>Certificates of Enrollment</u>:

- You may request these from the Registrar's Office.
- Be sure to request verification of full-time enrollment for every semester you've been enrolled. It is also possible to request proof of full-time pre-registration for next semester, if you have pre-registered.

# • Other reminders:

- o If you have been outside the U.S. for more than five months and have not been enrolled at K-State during this time, you may need a new visa to re-enter the U.S. Please consult with an advisor at the ISSS and a representative at the embassy in your home country.
- Expect long lines and slow processes because documents will be reviewed closely at Embassies, Consulates, airports and U.S. ports of entry. Do not be alarmed if you are pulled aside at the port of entry for further questioning.
- o Contact your own consulate to determine if there are any travel precautions.
