Under my leadership, Classics enrollment has bucked the K-State trend of declining enrollment. From Fall 2018 to Spring 2022, enrollment by Student Credit Hour in the Department of Modern Languages has declined 36% overall, with some individual languages declining up to 60%. In this same period, enrollment in the Classics section—including Medical Terminology and its course delivered annually via History—has increased 24.7%.

In this same period, ten Classics minors have received funded awards from the College to pursue guided research with the section. I have also cultivated outside funding opportunities which help award several thousand dollars annually of additional need-based scholarships; moreover, they fund a Social Media worker. I have also cultivated paid Classics Minor student workers who act as TAs for my Medical Terminology course in both spring and summer.
