K-State Transdisciplinary Applied Learning Grant Application Spring 2025

As part of Next-Gen K-State efforts, incentive grants are available as seed funds for the purposes of creating and/or expanding transdisciplinary applied learning experiences. These funds are to be used **to catalyze transdisciplinary applied learning across at least two units at K-State to launch pilot programming.**

Funding range: \$5,000–\$40,000 total, to be expended over a 1–2 year period.

Eligible to apply: K-State Faculty or Staff members with at least one year of service to the university; at least two

applicants from different departments or units at K-State are required per application.

Support: Department or Unit letter of support required for all members of the applicant team.

Match: none required

This application will ask basic logistical questions, then will break questions into 5 sections that specifically address the ALE Framework. Finally, a few other general questions will be asked. If you will not be completing this application in one sitting, we recommend keeping answers in a word processing document to avoid losing work.

Transdisciplinary: experiences designed and implemented by faculty from different disciplines working jointly to create new applied learning opportunities that integrate and move beyond discipline-specific pedagogies.
