In all other respects, this scholarship shall be awarded without restriction to race, sex, gender identity, national origin, religion, age, sexuality, or disability.	
Eligibility	The applicant of the scholarship must meet the following criteria to receive the scholarship. If applicant does not meet all of the criteria, they may address and appeal in their essay to be submitted.	
	1. The recipient(s) of this scholarship will be a student properly enrolled in any curriculum at Kansas State University.	
	2. The recipient(s) must have a minimum cumulative GPA of 2.5, based on a 4.0 scale.	
	3. The recipient(s) must be a permanent resident of the United States.
