## UNIVERSITY MISSION

The mission of Kansas State University is to foster excellent teaching, research and service that develop the highly skilled and educated citizenry necessary to advancing the well-being of Kansas, the nation and the international community.

## THE OPPORTUNITY

The Vice President for Student Life and Dean of Students ("VPSL & DOS") is responsible for fostering a commitment to student success by actively developing, implementing, and maintaining programs and services that enrich student learning, build and maintain a strong sense of community, and support the social and personal development of students at K-State. K-State is proud of the family-oriented environment that is central to the campus culture and it is critical that the new Vice President for Student Life and Dean of Students continues to foster this environment and build upon it as a foundation.

As a member of the President's Cabinet and direct report to the President, the VPSL & DOS provides institutional leadership for developing, delivering, evaluating and refining a cohesive and coordinated vision and strategies for student life on campus to support student access, learning, success and an optimal student experience. The VPSL & DOS will serve as an advocate for a student-responsive institution that focuses and fosters a culture of excellence and quality service orientation within all areas of responsibilities.

The VPSL & DOS has leadership and oversight over the Division of Student Life, which includes the following departments and programs: the Office of Student Life ( including the Center for Student Involvement, Student Access Center, Non-Traditional and Veterans Services, Center for Advocacy, Response, and Education and the LGBT Resource Center), the Office of Diversity and Multicultural Student Affairs, Housing and Dining Services, K-State Student Union, Recreational Services, Lafene Health Center, Counseling Services, Career Center, Parents & Family Relations, and Military and Veterans Affairs. The VSPL & DOS also serves as a leader in collaborative efforts with other areas of the University and works closely with the Provost and other senior university leadership, particularly in the areas of Enrollment and Student Success.

## Core duties and responsibilties:

The Vice President for Student Life and Dean of Students will be responsible for the following duties:

- Provide executive-level leadership, strategic planning, oversight, and coordination of all units in the Division of Student Life in the areas of programming, policy development, human resources, facilities, and fiscal resource management.
- Provide leadership for the development and implementation of high-quality and studentcentered approaches to support student success in non-academic dimensions of student university experiences. Examples include residential housing and residential life, diversity and inclusion activities, student activities and events, student clubs and

- organizations, student government, student conduct, wellness and well-being, accommodation of disabilities, access programs, career and skill counseling, and placement services.
- Provide leadership for the development and implementation of high-quality and studentcentered approaches to support student success in non-academic dimensions of student university experiences. Examples include residential housing and residential life, diversity and inclusion activities, student activities and events, student clubs and organizations, student government, student conduct, wellness and well-being, accommodation of disabilities, access programs, career and skill counseling, and placement services.
- Organize and unite the distinctive functions under the VPSL & DOS's purview to leverage resources, services, and programming to best meet the needs of the K-State student body.
- Oversee an assessment plan for the functional areas with learning outcomes and program outcomes – taking into consideration the K-State mission and that of the division.
- Train, develop, and manage departmental leaders; provide them with shared and individual goals for which they are accountable. Develop effective controls to guide effort toward expected outcomes.
- Promote positive student relations by maintaining open and effective lines of communication with student groups and student leaders and serving as a strong advocate for the non-academic, extra- and co-curricular needs of students.
- · Oversee a complex multi-million dollar budget.
- Provide on-site emergency preparation / response coverage as necessary.
- Respond to student crises, issues and concerns; mobilize campus resources to respond to emergencies, crisis situations and disruptions that involve students; and maintain a visible presence on campus and during studentfocused / -sponsored activities.
- Apply and enforce the Student Code of Conduct.
- Partner with the KSU Foundation to further philanthropic support of the Division's programs and initiatives.

Kansas State University educates nearly 22,000 of tomorow's potential leaders and provides some of the best global food systems and biosecurity research in the world. The university is progressing toward its goal of becoming a Top 50 public research university by 2025.



- A letter of interest describing relevant experiences and interest in the position.
- Curriculum vitae or resume.
- Three professional references, including titles, addresses, phone numbers and email addresses.
- Leadership statement.

Applications and nominations should be electronically submitted at <u>k-state.edu/careers</u>.

The search committee will accept applications and nominations until April 1, 2019. The committee will begin identifying candidates to interview on April 4, 2019, and initial interviews will take place April 15-19, 2019.
