Thank you for your kind words regarding our men's and women's golf programs. 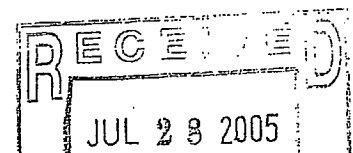


Dear Tim:
