### How to get an SSN or ITIN.

If you do not have an SSN or ITIN you may apply for one but first contact the KSU International Student Center, 785-532-6448, to determine whether you are eligible for one or if you may need an ITIN. To apply for an SSN, get Form SS-5, Application for a Social Security Card, from the local Social Security Administration, 1121 Hudson Ave, Manhattan, KS 1-877-840-5741 or online <u>https://www.ssa.gov/ssnumber</u>. You must apply for an ITIN through the IRS.
