



Beta Kappa Centennial Anniversary

After a tumultuous beginning at Southwest Kansas College which resulted in the chapter becoming defunct in 1897, the Beta Kappa Chapter of Sigma Nu was installed at Kansas State Agricultural College on May 24, 1913. On March 2, more than 170 Beta Kappa alumni gathered at the K-State Alumni Center for a banquet in celebration of the centennial anniversary of the Beta Kappa Chapter of Sigma Nu at Kansas State University. The program included a message from Amy Button Renz, President of the KSU Alumni Association and a presentation of the centennial anniversary certificate from Charlie Eitel, Regent of Sigma Nu Fraternity.

Also included in the program was a brief history of the Beta Kappa chapter from its beginning at Southwest Kansas College in 1892 provided by historian **Robert Hudson, BK 1617** and a video

welcome from **Alex Beemer, BK 1613**; **Tyler Maddox, BK 1615**; and **Zach Pitts, BK 1622** who were in Prague for the semester on a study abroad experience. Dinner was preceded by grace and Chapter Eternal performed by chaplain **Tyler Fischer, BK 1648**. During dinner the group cheered on the Cats who narrowly overtook the Baylor Bears in a nail-biter finish of 64-61. The win added more energy to an already electric event. Following dinner, **Dean Bergquist, BK 908**, delivered the keynote address. Brother Bergquist spoke on the need to focus our lives on the ideals of Sigma Nu—Love, Truth and Honor—and that we are Sigma Nu's for life. We must extend the Helping Hand to our brothers to improve our collective lives as well as theirs. To be successful in the future, we need a strong Alumni/Active partnership working together to create the foundation for an exemplary lifelong Sigma Nu experience.

The evening concluded with a few words from Regent Charlie Eitel before presenting the certificate to Eminent Commander, **Alex Newell, BK 1631**.

The highlight of the evening was a video interview with **Leroy Christopher**, **BK** 383, who pledged in the Fall of 1936 the year the current chapter house opened. Brother Christopher was interviewed a week prior to the banquet by **Ben Rinehart**, **BK** 1644; **Eric Sieck**, **BK** 1645; and **Tyler Nelson**, **BK** 1647. Dear Alumni Brothers.

Since last fall, the Beta Kappa House Corporation has been very busy across a number of fronts to improve the chapter house and the overall fraternity experience of our collegiate membership. After a January planning meeting to outline our needs and goals, things got off to

a great start with an Alumni/Active work weekend organized by Alumni Brothers Dave Gnaegy, BK 985 and Tony Cummings, BK 915. Many needed repairs were done. The living room floor was sealed, kitchen thoroughly cleaned, mailbox area rebuilt and all the public areas and stairwell were painted. Our Housemother, Monica Strathman, even got a new door for her apartment!

The result of this general fix up was a great boost to our collective pride, as we could see the potential of our plans to renovate and expand the house. Phase I will begin this summer which will renovate all the existing study rooms, make much needed exterior repairs and complete selected landscaping projects. This will get us back to a base line condition of the living space and grounds to launch Phase II construction. The initial plans for Phase II will expand the study rooms into suites with options to reconfigure the third floor dorm into living space. We will also expand and remodel the kitchen. A larger Phase III expansion is in the planning stages for a multipurpose area and expanding the capacity of the house.

Many other K-State fraternities have either extensively remodeled or built entirely new chapter houses in the past ten years. If we are to compete for the high quality student we want as a Sigma Nu, we must meet this challenge. Alumni Brothers from previous generations stood up to provide a legacy that has lasted over 100 years on campus and now our time has come to insure its continued success.

We have begun the selection process for a professional fundraiser to assist us in securing the needed resources for this undertaking. During the coming months, you will be hearing more from us (and them) as we prepare to restore our Beta Kappa chapter house to its traditional position as the first choice of young men on the K-State campus seeking an exceptional Greek experience.
