In 2015, USAID and USDA/FAS awarded a Cooperative Agreement to Rutgers University to lead a Research Consortium focused on evaluating the effectiveness of agricultural, food and nutrition policies in Feed the Future countries and regions. Over the past six years, the Consortium -- formally known as the Feed the Future Policy Research Consortium and since 2018 funded as an Associate Award under the Sustainable Intensification Innovation Lab — has supported the achievement of the U.S. Government Global Food Security Strategy objectives by contributing to the improvement of policy approaches and outcomes. Specifically, the Consortium sought to:

- 1. Develop an expanded version of agricultural transformation and the policy agenda that it implies.
- 2. Study the impact of policy change and policy systems as they relate to agriculture, food and nutrition.
- 3. Develop novel indicators and collect relevant data for use in evidence-based policy analysis.
- 4. Support food and agricultural policy responses to the COVID-19 pandemic.

In this Conference to mark its end, Consortium members will present the results of their research activities, important lessons learned and the implications they hold for USAID's policy related work. The Conference may be of interest not only to USAID staff working on food policy issues, but also to implementing partners, development agencies, African policy makers and other researchers.
