2006 KANSAS HORTICULTURAL SURVEY

The 2006 Kansas Horticultural Survey showed that the horticulture industry added over one billion dollars in sales and expenditures to the Kansas economy during This does not include the volume of horticulturally related gross sales through chain store retail outlets. Lawn care firm sales and services accounted for a little over \$300 million of this total while other surveyed turf installation and maintenance expenditures accounted for nearly \$420 million. Other large contributors were nurseries/greenhouses, \$157 million; florists, \$66.5 million; and arborists \$61.2 million. Over 788,000 acres in Kansas were involved in Horticulture activities. The industry groups included in this survey, not including households which do most of the work themselves, had nearly 36,000 paid and unpaid employees involved in their operations during 2006.

HORTICULTURE PRODUCTION

The gross value of sales for the horticultural enterprises involved in the production of fruits, berries, nuts, vegetables, grapes, medicinal plants, Christmas trees, and sod totaled \$31.0 million in 2006. This compares with sales of \$15.1 million in 2000. Gross sales from vegetable/melons operations increased 236 percent since 2000. There were 25,460 acres in production for these horticultural enterprises in 2006. In 2000, there

were 18,430 acres utilized by these horticultural enterprises. There were 3,300 paid and unpaid employees on these operations in 2006. Nut production utilized 21.3 percent of the production acres while generating only 3.3 percent of the gross sales. On the other hand, sod producers generated 43.3 percent of the gross sales utilizing only 30.2 percent of the acres.

The Horticultural Industry Survey, as its basic goal, attempted to survey only firms having horticultural production and sales in Kansas as their primary operations. Consequently, this survey did not measure the volume of horticulturally related gross sales through chain store retail outlets.

NURSERIES and GREENHOUSES

The Nursery and Greenhouse Industry totaled \$156.7 million of gross sales in 2006. These operations had 4,290 acres utilized for field production of ornamental trees and shrubs and 490 acres for container production of ornamental trees and shrubs. They had 8.2 million square feet of greenhouse production and had 4,700 paid and unpaid employees.

During 2006, Nurseries and Greenhouses marketed 36.9 percent of their sales through wholesale channels, 22.8 percent was sold through retail channels, 14.4 percent was for design and installation services, 8.3 percent was for retail sales of non-plant goods, 6.6 percent for landscape maintenance, and 2.5 percent for landscape irrigation. The residual 8.5 percent represented wholesale production sold to themselves, of which sod made up 4.9 percent.

Turf Installation and Maintenance

Total turf installation and maintenance expenditures at golf courses, airports, health care facilities, schools, parks and athletic fields, racetracks, households, and Kansas roadsides was nearly \$409 million in 2006.

Lawn Care Firms

Lawn care firms added a little over \$300 million in sales and services to the Kansas economy in 2006. They maintained nearly 434,000 acres of turf and had 9,600 paid and unpaid employees.

Florists

Florists contributed \$66.5 million to gross sales for the Horticulture Industry. This compares with \$63.2 million of gross sales in 2000. Florist operations grew only 3.5 percent of the plant production sold at the florist's location. These operations employed 1,500 paid and unpaid employees during 2006.

Arborists

The total gross value of sales and services provided by arborists in Kansas totaled \$61.2 million. This represented a 28% increase in gross sales from 2000. These services provided for the care and maintenance of trees, including cutting, pruning and shaping, tree surgery, and pest control. A total of 1,470 paid and unpaid employees provided this service.

Farmer's Market

Sales of horticultural products through farmer's markets totaled nearly \$1.0 million during 2006. Total production area used for these farmer's market sales were 359 acres. There were 310 paid and unpaid employees involved in these production and sales. The sales reported in this marketing outlet is comprised of the small producer and may not be a true reflection of the magnitude of total sales through the farmer's market. Sales of major producers were reflected in the gross sales of horticultural production

Purpose and Procedure

The Legislative initiative by the Kansas Association of Horticulture Industries (KAHI) in cooperation with the Kansas Department of Agriculture led to funds for this survey.

The 2006 Horticultural Survey is similar to surveys conducted in 1994 and 2000. These data estimate horticulture's impact on the State's economy. The lists of producers and businesses surveyed were developed through the cooperation of the various affiliated industry groups comprising the Kansas Horticultural Society and collaboration with Kansas State in University Department of Horticulture and the Kansas Department of Agriculture. Five questionnaire versions were used in the survey. Great effort was made to make the list used for this survey complete. However, this survey does not attempt to survey businesses selling bedding plants, trees and shrubs, and horticulturally-related non-good items through chain store-related outlets.
