

# Manhattan Ultimate Summer League 2009 Waiver & Parental Consent

What is Ultimate??

Ultimate combines the non-stop movement and athletic endurance of soccer with the aerial passing skills of football. A game of Ultimate is played by two seven-player squads with a Frisbee on a field similar to football. The object of the game is to score by catching a pass in the opponent's end zone. A player must stop running while in possession of the disc, but may pivot and pass to any of the other receivers on the field. Ultimate is a transition game in which players move quickly from offense to defense on turnovers that occur with a dropped pass, an interception, or a pass out of bounds. Ultimate is governed by Spirit of the Game™, a tradition of sportsmanship that places the responsibility for fair play on the players rather than referees. Parents are encouraged to watch.
