# President's Column

Dear Classified Employees:

As the new year begins, there are a few topics that the classified employees need to be aware of and that should be followed in the newspapers, television, and legislative website.

First is the change in the classified pay plan. Governor Bill Graves announced that effective February 4, 2001, the elimination of Pay Steps 1, 2, and 3 will occur in order to enhance recruitment, and to reduce turnovers of new hires. Employees currently on these steps will automatically be moved to Step 4, with Step 4 becoming the new entry level step. *http://www.da.state.ks.us/ps/subject/payinfo.htm*. This is an Executive Directive and does not require approval of the Kansas Legislature.

For the Fiscal year 2002, the Governor has recommended a 3% increase for the classified employees. This would be considered a "cost of living adjustment", and the increase would consist of a  $1 \frac{1}{2}$ % increase in July, and a  $1 \frac{1}{2}$ % increase in January 2002. However, the step movement will be suspended, and possibly reestablished in FY2003. The longevity bonuses will continue for FY 2002.

Of course, the Kansas Legislature is back in session. It's time to bring issues to the Legislators, and on Wednesday, February 14, 2001, a group of senators from KSU will be going to Topeka to meet with legislators. Please see the article in this newsletter for more information.

Last is the local issue of the proposal of a Transit System for KSU and the City of Manhattan. This is a proposed cooperative toward a solution to the "parking problem" on campus. This would affect students, faculty, and staff because of the proposed increase in parking permits, but with the flexibility to ride a bus to campus at a lesser expense.

These are only a few issues that are important to the classified employees. Please feel free to contact me or your senator with any questions or comments. Remember, monthly senate meetings are always open to classified employees. Classified Recognition Ceremony is scheduled for 2 p.m. May 24, 2001 in the K-State Union Ballroom

### Legislative Day

On Wednesday, February 14, 2001, the Classified Senators of Kansas State University are planning to attend Legislator's Day in Topeka at the State Capitol. All Classified Employees from the State of Kansas are also invited to attend and meet with Legislators on this day; however, State policy is that annual leave time must be used to attend.

The Classified Senate President from K ansas State University, Emporia State University, Kansas University, Pittsburg State University, Wichita State University, Ft. Hays University have made appointments with various legislators to discuss the combined position paper prepared at a Regents Classified Senate meeting in Pittsburg, K ansas, on September 30, 2000. #### Manhattan Transit Meeting/Impact on KSU

On Tuesday, January 9, 2001, the Manhattan City Commission received a report from the representatives of TransSystems Corporation regarding a possible transit system for the City of Manhattan. The implementation of this plan would be in cooperation with K ansas State University.

The plan was endorsed by the K-State Student Government, and presented as a way to address the campus parking situation and to also serve the community. Open houses were held at the KSU Student Union and Manhattan City Hall in November to discuss who would be served, transit routes, and reasons for using a transit service. The results of the study were presented.

The meeting concluded with the City Commission agreeing to go to the next step of planning. That step is to determine costs. The details of this Implementation Plan are expected to be completed Spring 2001 which will include the project expected to be paid by KSU.
